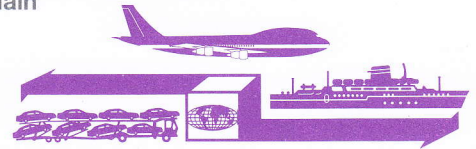

All risks marine insurance to be covered for

Insurance will only be covered if shipper expressly so instructs at the time of shipment. The insurance is governed by the policy and no further responsibility can be accepted by Cargo

Coverage as per Institute Cargo Clauses All Risks, Institute War Clauses and Institute Strike, Riots and Civil Commotion Clauses. If the new car value at destination is the declared insured value, underwriters will pay the full amount of repair / replacement costs but in no event more than the actual used car replacement value of the car for any loss, whether total or partial. If the declared insured value is less than the new car value at destination, underwriters will make deductions "new for old" on repair and replacement costs in proportion of insured sum to new car value at place of destination. Minor deficiencies due to normal use are not subject of this insurance. Used cars older than one year are insured excluding hairline scratches, chips, polish cracking and other minor paint damages as well as rust and oxidation unless evidently caused by direct contact with seawater.

Risks under the policy to terminate when taking over the car after discharge from overseas vessel at least 30 days after discharging at port of destination. Cargo and/or underwriters will not accept any liability for the mechanical defects of engine, transmission, clutch and/or electrical system.

Please note that the marine insurers are only liable for loss and damage noted on the Dock-Delivery-Receipt after discharging and prior to termination of insurance. No concealed loss or damage will be admitted.

Free from losses and/or damages noted upon physical takeover of the car at receiving location (acceptance for transport)

Underwriters shall not be liable to pay any claim unless complete claim papers are submitted within 6 month of the delivery of the car to customer.

In case of COD plus 10% collection fee.

Currency and/or bunker surcharge may be applicable at time of shipment

Above rates do not include any port fees, terminal charges, wharfage or any other charges at port of destination unless otherwise specified

The undersigned owner or designated person, herewith authorizes Cargo to proceed with shipment. All terms and provisions stated in this Reservation Form - Shipping Order are agreed to.
